**METROPOLITAN AREA EMPLOYMENT AND UNEMPLOYMENT — OCTOBER 2012**

Unemployment rates were lower in October than a year earlier in 329 of the 372 metropolitan areas, higher in 37 areas, and unchanged in 6 areas, the U.S. Bureau of Labor Statistics reported today. Three areas recorded jobless rates of at least 15.0 percent, while 41 areas registered rates of less than 5.0 percent. Two hundred eighty-eight metropolitan areas reported over-the-year increases in nonfarm payroll employment, 80 reported decreases, and 4 had no change. The national unemployment rate in October was 7.5 percent, not seasonally adjusted, down from 8.5 percent a year earlier.

**Metropolitan Area Unemployment (Not Seasonally Adjusted)**

In October, 35 metropolitan areas reported jobless rates of at least 10.0 percent, down from 80 areas a year earlier, while 180 areas posted rates below 7.0 percent, up from 107 areas in October of last year. Yuma, Ariz., and El Centro, Calif., recorded the highest unemployment rates in October, 29.8 and 28.1 percent, respectively. Bismarck, N.D., registered the lowest unemployment rate, 2.2 percent. A total of 213 areas recorded October unemployment rates below the U.S. figure of 7.5 percent, 149 areas reported rates above it, and 10 areas had rates equal to that of the nation. (See table 1 and the map.)

The largest over-the-year unemployment rate declines in October were registered in Pascagoula, Miss. (-3.1 percentage points), Elkhart-Goshen, Ind. (-2.9 points), and Ocala, Fla. (-2.8 points). Twenty-six additional areas had decreases of 2.0 percentage points or more. Elmira, N.Y., reported the largest over-the-year jobless rate increase (+1.1 percentage points), followed by Yuma, Ariz. (+1.0 point).

Among the 49 metropolitan areas with a Census 2000 population of 1 million or more, the highest unemployment rates in October were registered in Riverside-San Bernardino-Ontario, Calif., and Las Vegas-Paradise, Nev., 11.7 and 11.1 percent, respectively. The lowest jobless rate among the large areas was recorded in Oklahoma City, Okla., 4.9 percent. Forty-three large areas reported over-the-year unemployment rate decreases, four registered increases, and two had no change. Las Vegas-Paradise, Nev., experienced the largest unemployment rate decline from October 2011 (-2.5 percentage points). Three other large areas, all in Florida, reported rate decreases of at least 2.0 percentage points. Buffalo-Niagara Falls, N.Y., recorded the largest unemployment rate increase (+0.8 percentage point).

## **Metropolitan Division Unemployment (Not Seasonally Adjusted)**

Eleven of the most populous metropolitan areas are made up of 34 metropolitan divisions, which are essentially separately identifiable employment centers. In October 2012, Detroit-Livonia-Dearborn, Mich., registered the highest jobless rate among the divisions, 11.9 percent. Bethesda-Rockville-Frederick, Md., and Framingham, Mass., reported the lowest division rates, 4.8 and 4.9 percent, respectively. (See table 2.)

Twenty-seven of the metropolitan divisions recorded over-the-year jobless rate decreases in October, while seven registered increases. Fort Lauderdale-Pompano Beach-Deerfield Beach, Fla., and West Palm Beach-Boca Raton-Boynton Beach, Fla., posted the largest rate declines from a year earlier (-1.9 percentage points each). Eleven additional divisions had decreases of 1.0 percentage point or more. No division reported an unemployment rate increase over the year greater than 0.6 percentage point.

In 6 of the 11 metropolitan areas that contain divisions, the ranges between the highest and lowest division jobless rates were 2.0 percentage points or more in October 2012. Boston-Cambridge-Quincy, Mass.-N.H., recorded the largest rate difference among its divisions, 5.8 percentage points (Lawrence-Methuen-Salem, Mass.-N.H., 10.7 percent, compared with Framingham, Mass., 4.9 percent).

## **Metropolitan Area Nonfarm Employment (Not Seasonally Adjusted)**

In October, 288 metropolitan areas reported over-the-year increases in nonfarm payroll employment, 80 reported decreases, and 4 had no change. The largest over-the-year employment increase occurred in New York-Northern New Jersey-Long Island, N.Y.-N.J.-Pa. (+128,000), followed by Houston-Sugar Land-Baytown, Texas (+95,800), and Los Angeles-Long Beach-Santa Ana, Calif. (+78,300). The largest over-the-year percentage gain in employment was reported in Lafayette, La. (+8.5 percent), followed by Elkhart-Goshen, Ind. (+7.3 percent), and Columbus, Ind. (+7.2 percent). (See table 3.)

The largest over-the-year decrease in employment occurred in Milwaukee-Waukesha-West Allis, Wis. (-5,800), followed by Colorado Springs, Colo. (-4,400), and Augusta-Richmond County, Ga.-S.C. (-3,500). The largest over-the-year percentage decrease in employment was reported in Lawton, Okla. (-3.9 percent), followed by Auburn-Opelika, Ala., and Dalton, Ga. (-3.8 percent each), and Las Cruces, N.M. (-3.7 percent).

Over the year, nonfarm employment rose in 36 of the 37 metropolitan areas with annual average employment levels above 750,000 in 2011. The largest over-the-year percentage increases in employment in these large metropolitan areas were posted in Houston-Sugar Land-Baytown, Texas (+3.6 percent); Austin-Round Rock-San Marcos, Texas, and San Jose-Sunnyvale-Santa Clara, Calif. (+3.5 percent each); and Seattle-Tacoma-Bellevue, Wash. (+3.1 percent). The only large metropolitan area that reported a percentage decrease was Milwaukee-Waukesha-West Allis, Wis. (-0.7 percent).

## **Metropolitan Division Nonfarm Employment (Not Seasonally Adjusted)**

Nonfarm payroll employment data were available in October 2012 for 32 metropolitan divisions, which are essentially separately identifiable employment centers within a metropolitan area. Twenty-eight of the 32 metropolitan divisions reported over-the-year employment gains, while 3 reported losses and 1 reported no change. The largest over-the-year increases in the metropolitan divisions occurred in New York-White Plains-Wayne, N.Y.-N.J. (+113,500), and Los Angeles-Long Beach-Glendale, Calif. (+57,800). The over-the-year decreases in the metropolitan divisions were in Detroit-Livonia-Dearborn,

Mich. (-3,400), Nashua, N.H.-Mass. (-1,700), and Fort Lauderdale-Pompano Beach-Deerfield Beach, Fla. (-1,100). (See table 4.)

The largest over-the-year percentage increase in employment among the metropolitan divisions was reported in San Francisco-San Mateo-Redwood City, Calif. (+3.4 percent), followed by Seattle-Bellevue-Everett, Wash. (+3.1 percent), and Tacoma, Wash. (+3.0 percent). The largest over-the-year percentage decrease in employment occurred in Nashua, N.H.-Mass. (-1.4 percent).

#### **Current Employment Statistics (CES) Data Error**

BLS has identified errors in the state government employment data in the Lubbock, Texas metropolitan statistical area (31180). Federal and state government data in this area will be suppressed from 1990 forward while we research the full scope of the errors. BLS plans to release the corrected series concurrent with the CES State and Area benchmark release on March 18, 2013. # Technical Note

This release presents labor force and unemployment data from the Local Area Unemployment Statistics (LAUS) program (tables 1 and 2) for 372 metropolitan statistical areas and metropolitan New England City and Town Areas (NECTAs), plus 8 areas in Puerto Rico. Estimates for 34 metropolitan and NECTA divisions also are presented. Nonfarm payroll employment estimates from the Current Employment Statistics (CES) program (tables 3 and 4) are provided for most of the same areas. State estimates were previously published in the news release, *Regional and State Employment and Unemployment*, and are republished in this release for ease of reference. The LAUS and CES programs are both federal-state cooperative endeavors.

## Labor force and unemployment—from the LAUS program

**Definitions.** The labor force and unemployment data are based on the same concepts and definitions as those used for the official national estimates obtained from the Current Population Survey (CPS), a sample survey of households that is conducted for the Bureau of Labor Statistics (BLS) by the U.S. Census Bureau. The LAUS program measures employment and unemployment on a place-of-residence basis. The universe for each is the civilian noninstitutional population 16 years of age and over. *Employed* persons are those who did any work at all for pay or profit in the reference week (the week including the 12th of the month) or worked 15 hours or more without pay in a family business or farm, plus those not working who had a job from which they were temporarily absent, whether or not paid, for such reasons as labor-management dispute, illness, or vacation. *Unemployed* persons are those who were not employed during the reference week (based on the definition above), had actively looked for a job sometime in the 4-week period ending with the reference week, and were currently available for work; persons on layoff expecting recall need not be looking for work to be counted as unemployed. The *labor force* is the sum of employed and unemployed persons. The *unemployment rate* is the number of unemployed as a percent of the labor force.

**Method of estimation.** Estimates for states, the District of Columbia, the Los Angeles-Long Beach-Glendale metropolitan division, and New York City are produced using time-series models with real-time benchmarking to national CPS totals. Model-based estimation was extended to the following areas and their respective balances of state in 2005: the Chicago-Joliet-Naperville, IL Metropolitan Division; Cleveland-Elyria-Mentor, OH Metropolitan Statistical Area; Detroit-Warren-Livonia, MI Metropolitan Statistical Area; Miami-Miami Beach-Kendall, FL Metropolitan Division; New Orleans-Metairie-Kenner, LA Metropolitan Statistical Area; and Seattle-Bellevue-Everett, WA Metropolitan Division. (Model-based estimation of the New Orleans-Metairie-Kenner metropolitan area was suspended following Hurricane Katrina; the indirect estimation methods described below will be used for this area until further notice.) Modeling improves the statistical basis of the estimation for these areas

and provides important tools for analysis, such as measures of errors and seasonally adjusted series. For all other substate areas in this release, estimates are prepared through indirect estimation procedures using a building-block approach. Employment estimates, which are based largely on “place of work” estimates from the CES program, are adjusted to refer to place of residence as used in the CPS. Unemployment estimates are aggregates of persons previously employed in industries covered by state unemployment insurance (UI) laws and entrants to the labor force data from the CPS. The substate estimates of employment and unemployment, which geographically exhaust the entire state, are adjusted proportionally to ensure that they add to the independently estimated state or balance-of-state totals. A detailed description of the estimation procedures is available from BLS upon request.

**Annual revisions.** Labor force and unemployment data shown for the prior year reflect adjustments made at the end of each year, usually implemented with January estimates. The adjusted model-based estimates reflect updated population data from the U.S. Census Bureau, any revisions in the other data sources, and model reestimation. All substate estimates are reestimated and adjusted to add to the revised model-based estimates.

## Employment—from the CES program

**Definitions.** Employment data refer to persons on establishment payrolls who receive pay for any part of the pay period that includes the 12th of the month. Persons are counted at their place of work rather than at their place of residence; those appearing on more than one payroll are counted on each payroll. Industries are classified on the basis of their principal activity in accordance with the 2007 version of the North American Industry Classification System.

**Method of estimation.** The employment data are estimated using a “link relative” technique in which a ratio (link relative) of current-month employment to that of the previous month is computed from a sample of establishments reporting for both months. The estimates of employment for the current month are obtained by multiplying the estimates for the previous month by these ratios. Small-domain models are used as the official estimators for the approximately 39 percent of CES published series which have insufficient sample for direct sample-based estimates.

**Annual revisions.** Employment estimates are adjusted annually to a complete count of jobs, called benchmarks, derived principally from tax reports that are submitted by employers who are covered under state unemployment insurance (UI) laws. The benchmark information is used to adjust the monthly estimates between the new benchmark and the preceding one and also to establish the level of employment for the new benchmark month. Thus, the benchmarking process establishes the level of employment, and the sample is used to measure the month-to-month

changes in the level for the subsequent months.

### **Reliability of the estimates**

The estimates presented in this release are based on sample surveys, administrative data, and modeling and, thus, are subject to sampling and other types of errors. Sampling error is a measure of sampling variability—that is, variation that occurs by chance because a sample rather than the entire population is surveyed. Survey data also are subject to nonsampling errors, such as those which can be introduced into the data collection and processing operations. Estimates not directly derived from sample surveys are subject to additional errors resulting from the particular estimation processes used. The sums of individual items may not always equal the totals shown in the same tables because of rounding. Unemployment rates are computed from unrounded data and thus may differ slightly from rates computed using the rounded data displayed in the tables.



