EMPLOYER COSTS FOR EMPLOYEE COMPENSATION – MARCH 2025

Employer costs for employee compensation for **civilian** workers averaged \$47.92 per hour worked in March 2025, the U.S. Bureau of Labor Statistics reported today. Wages and salaries averaged \$32.92, while benefit costs averaged \$15.00. Total employer compensation costs for civilian workers were \$18.08 at the 10th wage percentile, \$35.59 at the 50th (median) wage percentile, and \$92.66 at the 90th wage percentile. (See charts 1 and 2 and tables A and 1.)

Total employer compensation costs for **private industry** workers averaged \$45.38 per hour worked in March 2025. Wages and salaries averaged \$31.89 per hour worked and accounted for 70.3 percent of employer costs, while benefit costs averaged \$13.49 per hour worked and accounted for the remaining 29.7 percent. Total employer compensation costs for private industry workers were \$17.55 at the 10th wage percentile, \$32.97 at the 50th (median) wage percentile, and \$88.34 at the 90th wage percentile. Total employer compensation costs for **state and local government** workers averaged \$64.00 per hour worked in March 2025. Wages and salaries averaged \$39.42 and accounted for 61.6 percent of employer costs, while benefit costs averaged \$24.58 and accounted for 38.4 percent. Total employer compensation costs for state and local government workers were \$26.97 at the 10th wage percentile, \$60.16 at the 50th (median) wage percentile, and \$107.61 at the 90th wage percentile. Chart 1. Employer costs per hour worked by ownership, March 2025





Chart 2. Employer total compensation costs per hour worked by wage percentile, March 2025



Compensation percentiles are provided in nominal (current dollar) and real (constant dollar) values. Constant dollar estimates remove the effect of changes in consumer prices, such that compensation estimates are comparable on a same-dollar basis. Each year the constant dollar (real) estimates are updated to reflect the most recent reference period.

In March 2025, wages and salaries in the private industry were \$14.28 at the 10th wage percentile, \$23.18 at the 50th (median) wage percentile, and \$59.25 at the 90th wage percentile. (See charts 3 and 4 and table A.)

In March 2015, nominal (current dollar) private wages and salaries were \$8.63 at the 10th wage percentile, \$16.13 at the 50th (median) wage percentile, and \$41.48 at the 90th wage percentile. In March 2015, inflation-adjusted (constant dollar) private wages and salaries were \$11.69 at the 10th wage percentile, \$21.84 at the 50th (median) wage percentile, and \$56.18 at the 90th wage percentile. Chart 3. Private industry costs for wages and salaries by wage percentile, current dollar, March 2015-2025





Chart 4. Private industry costs for wages and salaries by wage percentile, constant dollar, March 2015-2025

TECHNICAL NOTE

Employer Costs for Employee Compensation (ECEC), a product of the National Compensation Survey (NCS), provides the average employer cost for wages and salaries as well as benefits per hour worked. The ECEC covers the civilian economy, which includes data from both private industry and state and local government. Federal government workers are excluded. Additionally, the self-employed, private household workers, and the agricultural sector are excluded from the private industry.

Total benefit costs consist of five major categories and include 18 benefits:

- Paid leave - vacation, holiday, sick, and personal leave;
- Supplemental pay - overtime and premium, shift differentials, and nonproduction bonuses;
- Insurance - life, health, short-term disability, and long-term disability;
- Retirement and savings - defined benefit and defined contribution; and
- Legally required benefits - Social Security [refers to Old-Age, Survivors, and Disability Insurance (OASDI) program], Medicare, federal and state unemployment insurance, and workers' compensation.

All workers are included in the benefit cost estimates including those that do not have plan access or do not participate. Costs are also affected by other factors such as cost sharing between employers and employees, plan features, and plan generosity. Sample size: Data for this reference period were collected from a probability sample of approximately 26,600 occupational observations selected from a sample of about 6,200 private industry establishments and approximately 7,400 occupational observations selected from a sample of about 1,400 state and local government establishments that provided data at the initial interview.

Measures of reliability: Relative standard errors (RSEs) provide users a tool to ascertain the quality of an estimate to ensure that it is within an acceptable range for their intended purpose. RSEs are available at www.bls.gov/web/ecec/ecec-rse.htm and the database query tool at www.bls.gov/ecec/data.htm.

Comparisons: Compensation cost levels in state and local government should not be directly compared with levels in the private industry. Differences between these sectors stem from factors such as variation in work activities and occupational structures.
