Changes in the 2015 Microdata Files from the 2014 Files

This document summarizes the changes in the 2015 files from the 2014 files for the Interview Survey and Diary Survey. Generally, there are three types of variable changes: Additions, deletions, and changes.

I. Sample Redesign

In 2015, Census introduced a new sample frame that is based on the 2010 Population Census. As a result, users cannot link all consumer units whose participation spanned the introduction of the new sample. For any micro-level longitudinal analysis, users may use the 2013 and 2014 data or the 2015 data. Data for the first quarter for 2015 are twice in PUMD, once in the 2000 sample frame and once in the 2010 sample frame. The 2014 data set uses the 2000 frame for the first quarter in 2015 (q151) and the 2015 data set uses the 2010 frame for first quarter in 2015 (q151). However, the two data file differ.

Due to the sample redesign, the first quarter of the 2015 data set does not contain data for January (q151). This omission affects some aggregate estimates of quarterly and annual time periods. To roughly estimate the missing January in those, inflate estimates of the first quarter by factors of 3/2 (q151) and estimates of 2015 by 12/11. Estimate of averages are not severely affected because the numerator and the denominator are both similarly affected. Calendar period estimates are not affected because all expenditures from January interviews fall into the q144 time period.

II. Bounding Interview Removal

Before 2015, the Interview Survey included a preliminary bounding interview, and each CU could be contacted up to five times over five quarters. The bounding interview recorded recent major expenditures for comparison with subsequent purchases. With the collection of 2015 data, CE cut the bounding interview to reduce respondent burden and save money.

Data in the 2015 PUMD package will contain CU's from both the old sample and the new. The DESFLG variable identifies which sample CE used to interview a CU and which stage in the interview process the data reflect. CU's from the 2000 sample will continue with interview designations (INTERI) of 2-5, while CU's from the 2010 sample will be stored using the interview designations of 1-4.

III. Variable Changes

Interview Survey

A. Variable Deletions in FMLI file

Beginning in 2015Q1 the following variables will be deleted from the FMLI files. In the 2015 data, CE deleted variables that were related to calculating the poverty threshold.
