The Employment Cost Index and the Impact on Medicare Reimbursements

Since the mid-1980's, the Bureau of Labor Statistics Employment Cost Index (ECI) has been a major source of data used by the Centers for Medicare and Medicaid Services (CMS) to determine the annual adjustment to Medicare reimbursements for health care service providers. CMS issues reimbursement guidelines under Medicare's Prospective Payment Systems (PPS), determining reimbursement rates (subject to approval by Congress) for Medicare-covered products and services to over one million health care providers. The PPS designates the level of payment for Medicare-covered products and services, adjusted annually, based on a number of factors including labor cost changes. The ECI measures the change in labor costs which CMS uses (in part) to determine annual adjustments to Medicare reimbursements made to health care providers in nine payment categories, resulting in an over \$12 billion reimbursement increase for 2022.1 (See Table 1.)

The PPS Hospital Price Index is a "market basket" used for three payment provider categories (hospital inpatient and acute care, hospital outpatient care, and hospice), resulting in an increase in reimbursements of almost \$9.6 billion based on ECI. The remaining payment provider categories accounted for over \$2.5 billion in reimbursement increases based on the ECI.

The example below provides information on how increases in a specific payment provider category are estimated using various ECI components.



Estimated Payment Example (using December 2022 ECI)

The PPS Hospital Price Index uses several ECI components to make annual adjustments to payments for various Medicare hospitalrelated payment provider categories. For example, Medicare reimbursements for hospital inpatient and acute care were approximately \$147 billion, according to 2022 CMS data. Approximately 76.0 percent of the Medicare update for the payment provider category is based on the ECI. Thus, a 1-percent increase in the ECI would result in a 0.760-percent increase in hospital payments. (See Table 2.)

Applying the total ECI-related weight (76.0 percent) to the calculated percent change using the December 2022 ECI (4.05%), would result in an approximate \$4.5 billion increase in Medicare payments for hospital inpatient and acute care.
