EMPLOYER COSTS FOR EMPLOYEE COMPENSATION – DECEMBER 2024

Employer costs for employee compensation for **civilian** workers averaged \$47.20 per hour worked in December 2024, the U.S. Bureau of Labor Statistics reported today. Wages and salaries averaged \$32.52, while benefit costs averaged \$14.68. (See chart 1 and tables 1 and 2.)

Total employer compensation costs for **private industry** workers averaged \$44.67 per hour worked in December 2024. Wages and salaries averaged \$31.47 per hour worked and accounted for 70.5 percent of employer costs, while benefit costs averaged \$13.20 per hour worked and accounted for the remaining 29.5 percent. (See chart 1 and tables 1 and 4.)

Total employer compensation costs for **state and local government** workers averaged \$63.46 per hour worked in December 2024. Wages and salaries averaged \$39.22 and accounted for 61.8 percent of employer costs, while benefit costs averaged \$24.23 and accounted for 38.2 percent. (See chart 1 and tables 1 and 3.)

Chart 1. Employer costs per hour worked by ownership, December 2024





Chart 2. Employer costs in the private industry and leisure and hospitality industry, December 2024




Total employer compensation costs for private industry workers in the leisure and hospitality industry averaged \$19.90 per hour worked in December 2024. Wages and salaries averaged \$16.25 and accounted for 81.7 percent of employer costs, while benefit costs averaged \$3.65 and accounted for 18.3 percent. (See chart 2 and table 4.)

Leisure and hospitality industry in the private sector

In the leisure and hospitality industry, total employer costs for sales and office occupations averaged \$20.47 per hour worked. Wages and salaries averaged \$16.66 per hour worked and accounted for 81.4 percent of employer costs, while benefit costs averaged \$3.81 per hour worked and accounted for the remaining 18.6 percent.

In the leisure and hospitality industry, total employer costs for service occupations averaged \$18.00 per hour worked. Wages and salaries averaged \$14.93 per hour worked and accounted for 82.9 percent of employer costs, while benefit costs averaged \$3.07 per hour worked and accounted for the remaining 17.1 percent. In the leisure and hospitality industry, total employer compensation costs averaged \$24.95 per hour worked for full-time workers and \$16.57 per hour worked for part-time workers. For full-time workers, employer costs for legally required benefits averaged \$1.98 per hour worked and accounted for 8.0 percent of employer costs. For part-time workers, employer costs for legally required benefits averaged \$1.70 per hour worked and accounted for 10.3 percent of employer costs. (See charts 4 and 5 and table 5.)

Chart 4. Employer costs in the leisure and hospitality industry by work status, December 2024




Chart 5. Employer benefit costs in the leisure and hospitality industry by work status, December 2024

TECHNICAL NOTE

Employer Costs for Employee Compensation (ECEC), a product of the National Compensation Survey, provides the average employer cost for wages and salaries as well as benefits per hour worked. The ECEC covers the civilian economy, which includes data from both private industry and state and local government. Federal government workers are excluded. Additionally, the self-employed, private household workers, and the agricultural sector are excluded from the private industry.

Total benefit costs consist of five major categories and include 18 benefit costs:

- Paid leave - vacation, holiday, sick, and personal leave;
- Supplemental pay - overtime and premium, shift differentials, and nonproduction bonuses;
- Insurance - life, health, short-term and long-term disability;
- Retirement and savings - defined benefit and defined contribution; and
- Legally required benefits - Social Security [refers to Old-Age, Survivors, and Disability Insurance (OASDI) program], Medicare, federal and state unemployment insurance, and workers' compensation.

All workers are included in the benefit cost estimates including those that do not have plan access or do not participate. Costs are also affected by other factors such as cost sharing between employers and employees, plan features, and plan generosity. Sample size: Data for this reference period were collected from a probability sample of approximately 26,700 occupational observations selected from a sample of about 6,300 private industry establishments and approximately 7,400 occupational observations selected from a sample of about 1,400 state and local government establishments that provided data at the initial interview.

Measures of reliability: Relative standard errors (RSEs) provide users a tool to ascertain the quality of an estimate to ensure that it is within an acceptable range for their intended purpose. RSEs are available at www.bls.gov/web/ecec/ecec-rse.htm and the database query tool at www.bls.gov/ecec/data.htm.

Comparisons: Compensation cost levels in state and local government should not be directly compared with levels in the private industry. Differences between these sectors stem from factors such as variation in work activities and occupational structures.
