Topic /Domain	Explanation
Contraceptive Choice (YPECC)	A set of 24 questions that covers Contraceptive choice. Asked of 902 select respondents (40% of males and 80% of females) in the 1983 birth cohort.
Domains of Influence (YDOM)	Who the respondent could turn to for advice about different areas.
Domains of Influence questions in other sections	Parental advice questions in the employment/schooling sections were under the threshold while those in finance were above. Similar self-administered section questions about education/training, job decision/career plans, and financial planning were under-used while those about relationships (asked in 4 rounds) were well-used.
Marriage (YMAR)	Whether spouse/partner had been married to/had children with someone else
Marriage (YMAR)	Relationship questions -- how often respondent/partner engaged in behavior such as screaming or yelling, compromising to resolve a disagreement, or expressing affection for each other
Parent self-administered (P6)	Parent's spouse/partner behavior towards the responding parent

Parent Background (P2)	Assorted background questions about the parent respondent's spouse/partner and the non-respondent biological parent.
Parent Life history (P3)	Questions about the parent respondent and the parent respondent's spouse/partner's work history
Parent Life history (P3)	Questions on whether the parent respondent lived with their child's grandparents since the oldest child was born
Parent Life history (P3)	2 questions about the parent's receipt of government aid were underused; the question asking about ever receiving fell above the threshold
Parent report of child history (PC8)	Childhood residence event history questions (e.g., lived with responding parent, if not where did they live) are underused. Two less detailed questions were above the threshold: whether the youth respondent lived with the parent since birth and the total number of places the respondent lived before 12.
Parent report of child history (PC8)	Report from the respondent parent on whether the biological father was legally identified, detailed questions on the custody of the youth respondent

Parent report of child history (PC8)	Rough schooling event history that indicates when the youth respondent entered the 1 st and 7 th grades, whether they missed months of school, whether they took classes during breaks, whether they took standardized tests, and if they received credit for college courses
Parent report of child history (PC8)	Age of youth respondent when they lived through a hard time is underused (whether they lived through hard times is used) and the ages in which the respondent spent 20+ hours in child care
Parent report of child history (PC8)	Responding parent report of ages when the youth respondent attended a Head Start program is underused (whether they attended is used)
Parent report of Child Income (PC10)	Small set of questions asking the responding parent about whether an independent youth respondent pays room and board or other money to the parent
Parent reports of child behavior (PC12)	The set of 3 questions about the parent's contact with the non-resident biological parent fell below the threshold; if there was contact, questions about the parent's behavior towards the non-resident parent and about the non-resident parent's behavior towards the parent were asked.
Self-Administered (YSAQ)	When the respondent last lived with their biological/adoptive mother or biological/adoptive father
Contact information (YCOI)	Questions about using the computer to send greeting cards or invitations and sharing photos, art, videos, etc...
Employment (YEMP)	Small set of questions for regular employees that asked who set the hours at their job, number of weekdays, whether they usually worked on weekends
Fertility (YFER)	Part of an experiment in which questions were asked as part of a section or as an independent section. This occurred in a few sections, but only the fertility sections were below the threshold.
