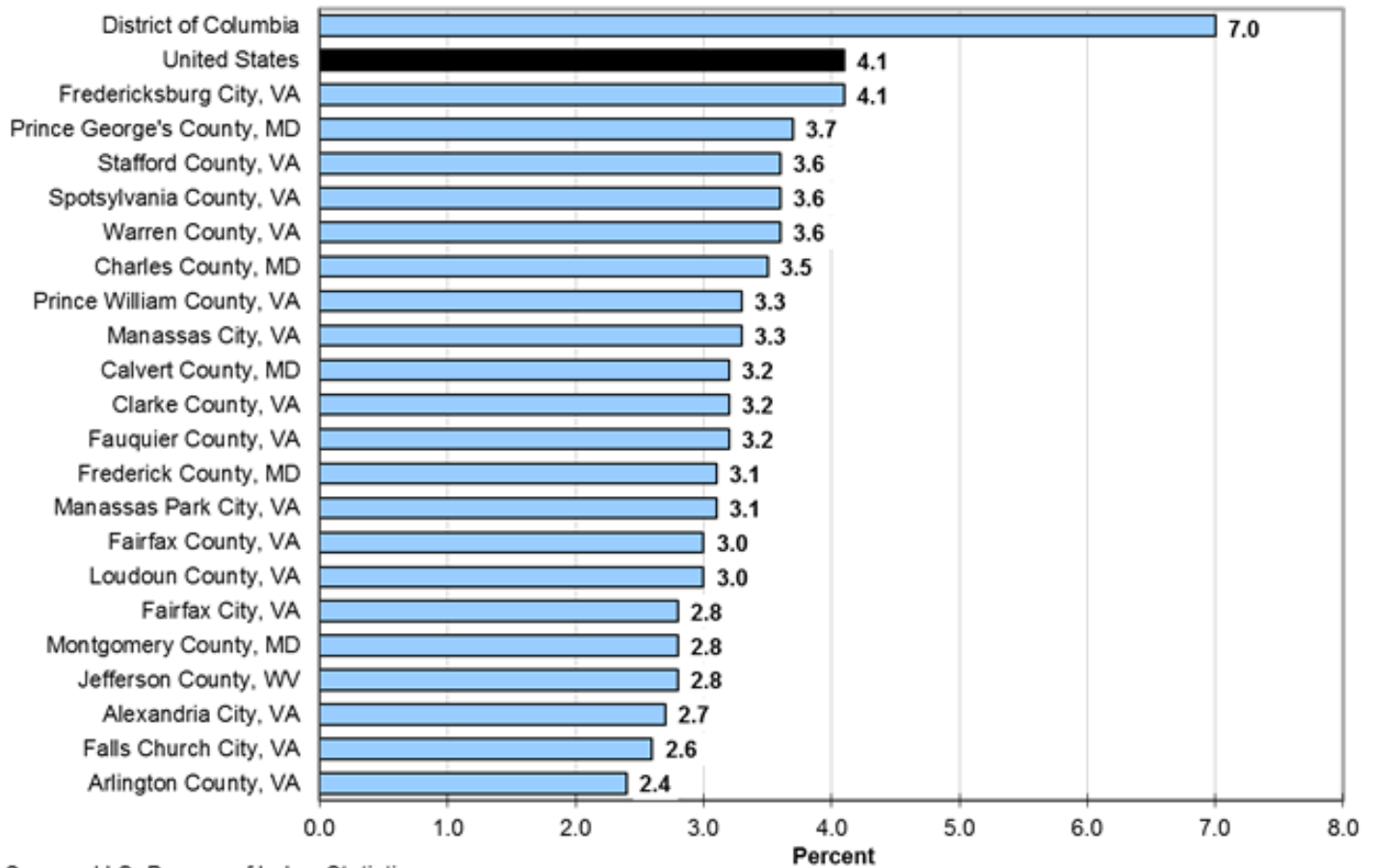

## **Unemployment in the Washington Area by County – September 2017**

### **District of Columbia had Unemployment Rate Higher than the National Average**

In September, Arlington County, VA, had the lowest unemployment rate in the Washington-Arlington-Alexandria, DC-VA-MD-WV Metropolitan Statistical Area at 2.4 percent, the U.S. Bureau of Labor Statistics reported today. Sheila Watkins, the Bureau's regional commissioner, noted that the District of Columbia had an unemployment rate of 7.0 percent, the highest among the 22 counties that make up the metropolitan area. The jobless rate in Fredericksburg City, VA, was equal to 4.1-percent national unemployment rate. The rates for the remaining 19 counties in the area ranged from 3.7 percent in Prince George's County, MD, to 2.6 percent in Falls Church City, VA. (See [chart 1](#) and [chart 2](#). All data in this release are not seasonally adjusted; accordingly, over-the-year analysis is used throughout.)

Unemployment rates in 21 of the 22 Washington-area counties were lower in September 2017 than in September 2016. Falls Church City, VA, had the smallest over-the-year decline at -0.2 percentage point while Fredericksburg City, VA, had the largest decline at -0.8 percentage point. Nineteen counties had jobless rate decreases ranging from -0.6 to -0.3 percentage point. (See [table A.](#)) The District of Columbia had an over-the-year rate increase of 0.8 percentage point. Nationally, the unemployment rate declined 0.7 percentage point since September 2016.

(1) Data for the Washington-Arlington-Alexandria, D.C.-Va.-Md.-W.Va. Metropolitan Statistical Area and its components are preliminary for the most recent month.

Jobless rates in 21 of the 22 counties in the Washington metropolitan area were lower unemployment rates in September 2017 than two years earlier. Five area counties had rate declines that exceeded the national decrease of 0.8 percentage point. Among these, Prince George's County, MD, had the largest two-year rate decline at 1.4 percentage points. Thirteen counties had unemployment rate declines that were smaller than the national decrease. The remaining three counties—Warren, VA; Manassas Park City, VA; and Jefferson, WV—had rate decreases that matched the national decline.

September 2017 unemployment rates for the two metropolitan divisions in the Washington-Arlington-Alexandria metropolitan area were 3.8 percent (Washington-Arlington-Alexandria, DC-VA-MD-WV.) and 2.9 percent (Silver Spring-Frederick-Rockville, MD). The jobless rate in the Silver Spring division declined -0.5 percentage point over the year; the rate in the Washington division decreased -0.3 point.

### Technical Note

This release presents unemployment rate data for states and counties from the Local Area Unemployment Statistics (LAUS) program, a federal-state cooperative endeavor.

*Definitions.* The labor force and unemployment data are based on the same concepts and definitions as those used for the official national estimates obtained from the Current Population Survey (CPS), a sample survey of households that is conducted for the Bureau of Labor Statistics (BLS) by the U.S. Census Bureau. The LAUS program measures employment and unemployment on a place-of-residence basis. The universe for each is the

civilian noninstitutional population 16 years of age and over. Employed persons are those who did any work at all for pay or profit in the reference week (the week including the 12<sup>th</sup> of the month) or worked 15 hours or more without pay in a family business or farm, plus those not working who had a job from which they were temporarily absent, whether or not paid, for such reasons as labor-management dispute, illness, or vacation. Unemployed persons are those who were not employed during the reference week (based on the definition above), had actively looked for a job sometime in the 4-week period ending with the reference week, and were currently available for work; persons on layoff expecting recall need not be looking for work to be counted as unemployed. The labor force is the sum of employed and unemployed persons. The unemployment rate is the number of unemployed as a percent of the labor force.

*Methods of Estimation.* The LAUS program is a hierarchy of non-survey methodologies for indirectly estimating employment and unemployment in states and local areas. Statewide data are produced through a modeling technique that uses estimates of payroll jobs from the Current Employment Statistics survey and unemployment insurance claims counts from the state workforce agencies to mitigate volatility in the direct CPS tabulations of employment and unemployment, respectively. Data for counties are developed through a building-block approach and adjusted proportionally to state model-based totals. For multi-county areas, such as the metropolitan areas and metropolitan divisions delineated by the Office of Management and Budget, estimates are summed from the data for their component counties. Estimates for cities and towns are produced through a disaggregation technique. *Annual revisions.* Labor force and unemployment data for prior years reflect adjustments made at the end of each year, usually implemented with January estimates. The adjusted estimates reflect updated population data from the U.S. Census Bureau, any revisions in the other data sources, and model reestimation. All substate estimates are reestimated and adjusted to add to the revised model-based estimates.

**Area definitions.** The substate area data published in this release reflect the standards and definitions established by the U.S. Office of Management and Budget, dated July 15, 2015. The **Washington-Arlington-Alexandria, DC-VA-MD-WV Metropolitan Statistical Area** includes the District of Columbia; Arlington, Clarke, Fairfax, Fauquier, Loudoun, Prince William, Spotsylvania, Stafford, and Warren Counties, and Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas, and Manassas Park Cities in Virginia; Calvert, Charles, Frederick, Montgomery, and Prince George's Counties in Maryland; and Jefferson County in West Virginia.

The **Washington-Arlington-Alexandria, DC-VA-MD-WV Metropolitan Division** includes the District of Columbia; Arlington, Clarke, Fairfax, Fauquier, Loudoun, Prince William, Spotsylvania, Stafford, and Warren Counties, and Alexandria, Fairfax, Falls Church, Fredericksburg, Manassas, and Manassas Park Cities in Virginia; Calvert, Charles, and Prince George's Counties in Maryland; and Jefferson County in West Virginia.

The **Silver Spring-Frederick-Rockville, MD Metropolitan Division** includes Frederick and Montgomery Counties in Maryland.
