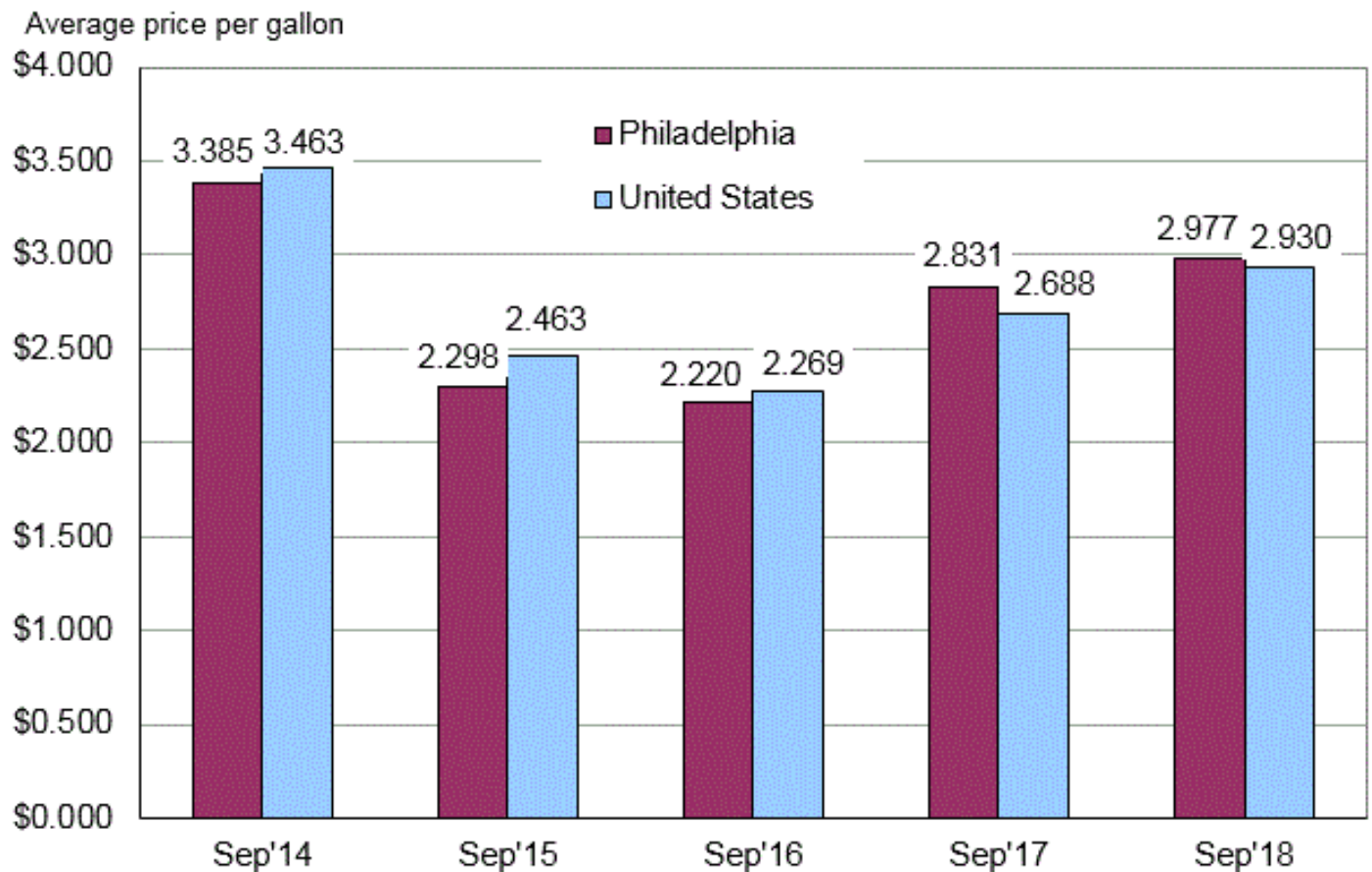

Average Energy Prices, Philadelphia-Camden-Wilmington – September 2018

Gasoline prices averaged \$2.977 a gallon in the Philadelphia-Camden-Wilmington area in September 2018, the U.S. Bureau of Labor Statistics reported today. Sheila Watkins, the Bureau's Regional Commissioner, noted that area gasoline prices were up 5.2 percent from last September when they averaged \$2.831 per gallon. Philadelphia-area households paid an average of 15.2 cents per kilowatt hour (kWh) of electricity in September 2018, unchanged from September 2017. The average cost of utility (piped) gas at \$1.096 per therm in September was 6.5 percent higher than its price of \$1.029 per therm a year earlier. (Data in this release are not seasonally adjusted; accordingly, over-the-year-analysis is used throughout.)

At \$2.977 a gallon, the price for gasoline in the Philadelphia area was close to the national average of \$2.930 a gallon in September 2018. From 2014 to 2017, local and national prices for gasoline in September differed by 6.7 percent or less. (See [chart 1](#) and [table 1](#).)

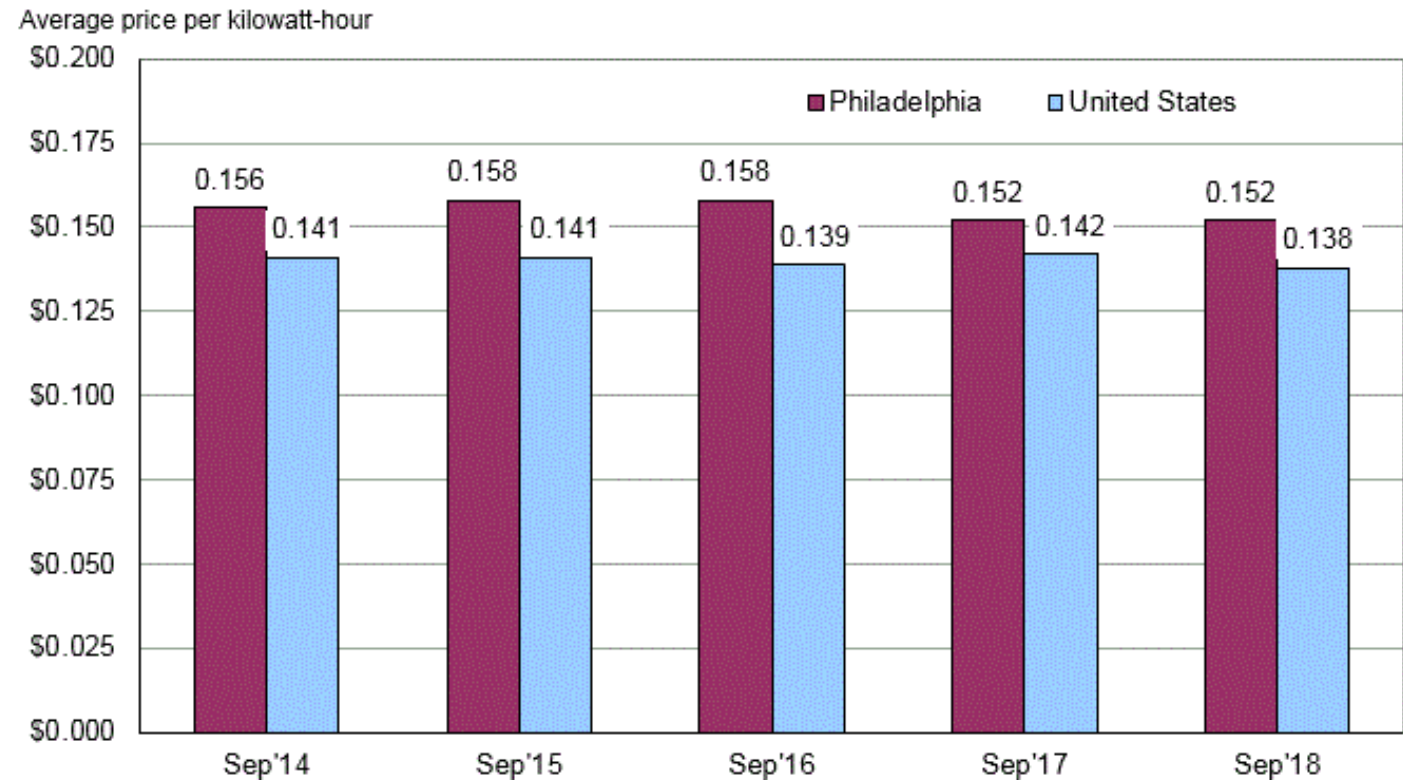
Chart 1. Average prices for gasoline, Philadelphia-Camden-Wilmington and United States, September 2014–September 2018

The 15.2 cents per kWh that Philadelphia households paid for electricity in September 2018 was 10.1 percent higher than the nationwide average cost of 13.8 cents per kWh. Last September, electricity prices in Philadelphia were 7.0 percent higher than the nation. From 2014 to 2016, prices paid by Philadelphia-area consumers for electricity in September exceeded the U.S. average by 10.6 percent or more. (See [chart 2.](#))

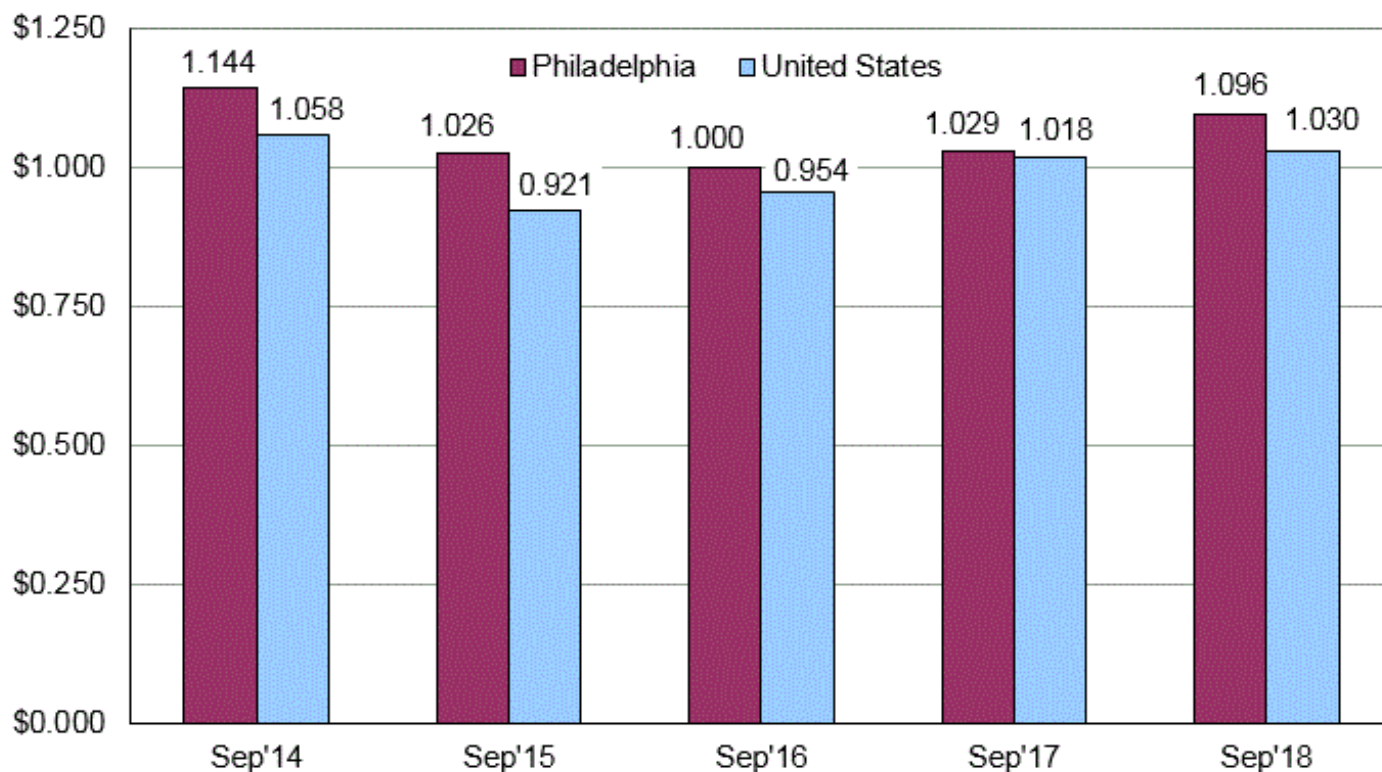
Chart 2. Average prices for electricity, Philadelphia-Camden-Wilmington and United States, September 2014–September 2018



The price paid by Philadelphia-area consumers for utility (piped) gas, commonly referred to as natural gas, was \$1.096 per therm in September 2018, 6.4 percent higher than the national average of \$1.030 per therm. Utility (piped) gas prices in the Philadelphia area were also above the national average in September for the previous four years, ranging from 1.1 percent to 11.4 percent higher. The Consumer Price Index for October 2018 is scheduled to be released on Wednesday, November 14, 2018, at 8:30 a.m. (ET).

Technical Note

Average prices are estimated from Consumer Price Index (CPI) data for selected commodity series to support the research and analytic needs of CPI data users. Average prices for electricity, utility (piped) gas, and gasoline are published monthly for the U.S. city average, the 4 regions, 9 divisions, 2 population size classes, 8 region/size-class cross-classifications, and the 23 largest local index areas. For electricity, average prices per kilowatt-hour (kWh) are published. For utility (piped) gas, average prices per therm are published. For gasoline, the average price per gallon is published. Average prices for commonly available grades of gasoline are published as well as the average price across all grades.

All eligible prices are converted to a price per normalized quantity. These prices are then used to estimate a price for a defined fixed quantity. The average price per kilowatt-hour represents the total bill divided by the kilowatt-hour usage. The total bill is the sum of all items applicable to all consumers appearing on an electricity bill including, but not limited to, variable rates per kWh, fixed costs, taxes, surcharges, and credits. This calculation also applies to the average price per therm for utility (piped) gas.
