## Occupational Employment and Wages in Nassau County-Suffolk County — May 2017

Workers in the Nassau County-Suffolk County Metropolitan Division had an average (mean) hourly wage of \$27.81 in May 2017, about 14 percent above the nationwide average of \$24.34, according to the U.S. Bureau of Labor Statistics. Chief Regional Economist Martin Kohli noted that, after testing for statistical significance, wages in the local area were higher than their respective national averages in 18 of the 22 major occupational groups, including management; healthcare practitioners and technical; and construction and extraction. The remaining four major occupational groups in the local area had wages that were similar to their respective national averages.

When compared to the nationwide distribution, local employment was more highly concentrated in 9 of the 22 occupational groups, including office and administrative support; education, training, and library; and personal care and service. Conversely, 12 groups had employment shares significantly below their national representation, including production; food preparation and serving related; and transportation and material moving. One occupational group—healthcare support—was chosen to illustrate the diversity of data available for any of the 22 major occupational categories. Nassau County-Suffolk County had 44,920 jobs in healthcare support occupations, accounting for 3.4 percent of local area employment, significantly higher than the 2.9-percent share nationally. The average hourly wage for this occupational group locally was \$17.28, significantly above the national wage of \$15.05.

Some of the larger detailed occupations within the healthcare support group included nursing assistants (14,380), home health aides (12,900), and medical assistants (4,420). Among the higher paying jobs in this group were physical therapist assistants and occupational therapy assistants, with mean hourly wages of \$30.60 and \$30.23, respectively. At the lower end of the wage scale were home health aides (\$11.97) and veterinary assistants and laboratory animal caretakers (\$13.90). Location quotients allow us to explore the occupational make-up of a metropolitan area by comparing the composition of jobs in an area relative to the national average. (See [table 1](#).) For example, a location quotient of 2.0 indicates that an occupation accounts for twice the share of employment in the area than it does nationally. In the Nassau County-Suffolk County Metropolitan Division, above-average concentrations of employment were found in some of the occupations within the healthcare support group. For instance, physical therapist aides were employed at 2.1 times the national rate in Nassau County-Suffolk County, and home health aides, at 1.7 times the U.S. average. On the other hand, nursing assistants had a location quotient of 1.1 in Nassau County-Suffolk County, indicating that this particular occupation’s local and national employment shares were similar.

These statistics are from the Occupational Employment Statistics (OES) survey, a federal-state cooperative program between BLS and State Workforce Agencies, in this case, the New York State Department of Labor.

## Notes on Occupational Employment Statistics Data

With the release of the May 2017 estimates, the OES program has replaced 21 detailed occupations found in the 2010 Standard Occupational Classification (SOC) with 10 new aggregations of those occupations. In addition, selected 4- and 5-digit North American Industry Classification System (NAICS) industries previously published by OES will no longer be published separately. Some of the 4-digit NAICS industries that are no longer being published separately will instead be published as OES-specific industry aggregations. A value that is statistically different from another does not necessarily mean that the difference has economic or practical significance. Statistical significance is concerned with the ability to make confident statements about a universe based on a sample. It is entirely possible that a large difference between two values is not significantly different statistically, while a small difference is, since both the size and heterogeneity of the sample affect the relative error of the data being tested.

### Technical Note

The Occupational Employment Statistics (OES) survey is a semiannual mail survey measuring occupational employment and wage rates for wage and salary workers in nonfarm establishments in the United States. The OES data available from BLS include cross-industry occupational employment and wage estimates for the nation; over 650 areas, including states and the District of Columbia, metropolitan statistical areas (MSAs), metropolitan divisions, nonmetropolitan areas, and territories; national industry-specific estimates at the NAICS sector, 3-, 4-, and selected 5- and 6-digit industry levels, and national estimates by ownership across all industries and for schools and hospitals. OES estimates are constructed from a sample of about 1.2 million establishments. Each year, two semiannual panels of approximately 200,000 sampled establishments are contacted, one panel in May and the other in November. Responses are obtained by mail, Internet or other electronic means, email, telephone, or personal visit. The May 2017 estimates are based on responses from six semiannual panels collected over a 3-year period: May 2017, November 2016, May 2016, November 2015, May 2015, and November 2014. The overall national response rate for the six panels, based on the 50 states and the District of Columbia, is 72 percent based on establishments and 68 percent based on weighted sampled employment. The unweighted sample employment of 82 million across all six semiannual panels represents approximately 58 percent of total national employment. The sample in the Nassau County-Suffolk County Metropolitan Division included 6,224 establishments with a response rate of 76 percent. (2) Estimates for detailed occupations do not sum to the totals because the totals include occupations not shown separately. Estimates do not include self-employed workers.

(3) The location quotient is the ratio of the area concentration of occupational employment to the national average concentration. A location quotient greater than one indicates the occupation has a higher share of employment than average, and a location quotient less than one indicates the occupation is less prevalent in the area than average.

(4) Annual wages have been calculated by multiplying the hourly mean wage by a "year-round, full-time" hours figure of 2,080 hours; for those occupations where there is not an hourly mean wage published, the annual wage has been directly calculated from the reported survey data.
