Consumer Price Index, South Region – January 2017

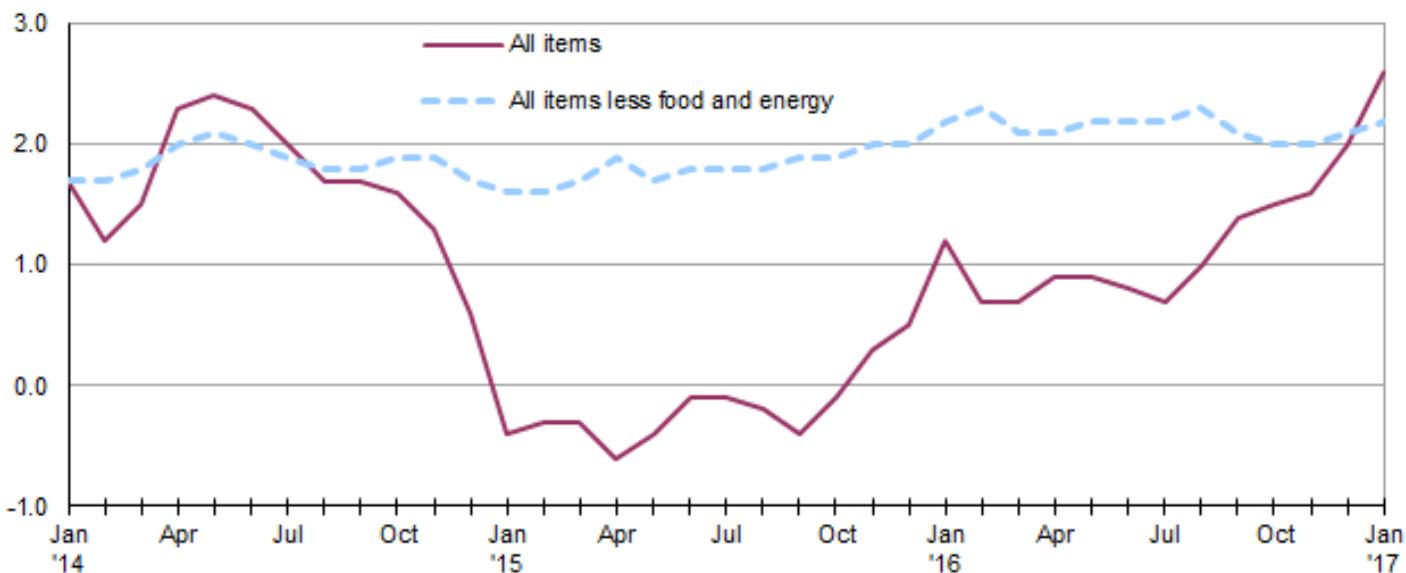
Regional prices up 0.5 percent over the month and 2.6 percent over the year

The Consumer Price Index for All Urban Consumers (CPI-U) for the South rose 0.5 percent in January, the U.S. Bureau of Labor Statistics reported today. The all items less food and energy index edged up 0.3 percent over the month. The energy index increased 3.2 percent and the food index rose 0.4 percent in January. (Data in this report are not seasonally adjusted. Accordingly, month-to-month changes may reflect the impact of seasonal influences.)

Over the last 12 months, the all items CPI-U advanced 2.6 percent. The all items less food and energy index increased 2.2 percent over the year reflecting price increases for shelter and medical care. (See [chart 1.](#))

Food

The food index increased 0.4 percent in January, as prices for food at home and for food away from home rose 0.4 percent each over the month.

The food index inched up 0.1 percent over the year. The food away from home index increased 2.0 percent since January 2016, while the food at home index declined 1.4 percent.

Energy

The energy index increased 3.2 percent in January, led by a 5.0-percent increase in motor fuel prices. Prices for electricity and utility (piped) gas service also advanced over-the-month, up 1.4 and 2.7 percent, respectively.

From January 2016—January 2017, energy prices advanced 12.3 percent, reflecting a 25.5-percent increase for motor fuel prices. Prices for utility (piped) gas service and electricity also increased, up 12.6 and 1.2 percent, respectively.

All items less food and energy

The all items less food and energy index edged up 0.3 percent in January. Shelter prices, up 0.3 percent, and a rise in medical care prices (0.7 percent) contributed to the increase.

Since January 2016, the all items less food and energy index advanced 2.2 percent—led by price increases in shelter (2.8 percent) and medical care (4.4 percent).

The Consumer Price Index for February 2017 is scheduled to be released on Wednesday, March 15, 2017.

Technical Note

The Consumer Price Index (CPI) is a measure of the average change in prices over time in a fixed market basket of goods and services. The Bureau of Labor Statistics publishes CPIs for two population groups: (1) a CPI for All Urban Consumers (CPI-U) which covers approximately 89 percent of the total population and (2) a CPI for Urban Wage Earners and Clerical Workers (CPI-W) which covers 28 percent of the total population. The CPI-U includes, in addition to wage earners and clerical workers, groups such as professional, managerial, and technical workers, the self-employed, short-term workers, the unemployed, and retirees and others not in the labor force.

The CPI is based on prices of food, clothing, shelter, and fuels, transportation fares, charges for doctors' and dentists' services, drugs, and the other goods and services that people buy for day-to-day living. Each month, prices are collected in 87 urban areas across the country from about 6,000 housing units and approximately

24,000 retail establishments—department stores, supermarkets, hospitals, filling stations, and other types of stores and service establishments. All taxes directly associated with the purchase and use of items are included in the index.

The index measures price changes from a designated reference date (1982-84) that equals 100.0. An increase of 16.5 percent, for example, is shown as 116.5. This change can also be expressed in dollars as follows: the price of a base period "market basket" of goods and services in the CPI has risen from \$10 in 1982-84 to \$11.65. In calculating the index, price changes for the various items in each location are averaged together with weights that represent their importance in the spending of the appropriate population group. Local data are then combined to obtain a U.S. city average. Because the sample size of a local area is smaller, the local area index is subject to substantially more sampling and other measurement error than the national index. In addition, local indexes are not adjusted for seasonal influences. As a result, local area indexes show greater volatility than the national index, although their long-term trends are quite similar. **NOTE: Area indexes do not measure differences in the level of prices between cities; they only measure the average change in prices for each area since the base period.**

The **South region** is comprised of Alabama, Arkansas, Delaware, District of Columbia, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, Oklahoma, South Carolina, Tennessee, Texas, Virginia, and West Virginia.
