

Union Members in Kentucky — 2021

In 2021, union members accounted for 7.2 percent of wage and salary workers in Kentucky, compared with 7.5 percent in 2020, the U.S. Bureau of Labor Statistics reported today. Regional Commissioner Janet S. Rankin noted that the union membership rate for the state was at its peak in 1989, when it averaged 14.8 percent, and at its low point in 2021 at 7.2 percent. (See chart 1 and table A.) Nationwide, union members accounted for 10.3 percent of employed wage and salary workers in 2021. The rate was down from 10.8 percent in 2020 when the rate increased due to a disproportionately large decline in the total number of nonunion workers compared with the decline in the number of union members. The 2021 unionization rate for the nation was the same as the 2019 rate of 10.3 percent. Since 1989, when state data became available, union membership rates in Kentucky have been below the U.S. average apart from one year.

Kentucky had 126,000 union members in 2021. In addition to these members, another 44,000 wage and salary workers in Kentucky were represented by a union on their main job or covered by an employee association or contract while not union members themselves.

Nationwide, 14.0 million wage and salary workers were union members in 2021 and 1.8 million wage and salary workers were not affiliated with a union but had jobs covered by a union contract. The number of wage and salary workers belonging to unions (14.0 million) was down by 241,000 from 2020.

In 2021, 30 states and the District of Columbia had union membership rates below that of the U.S. average, 10.3 percent, while 20 states had rates above it. (See table 1.) Ten states had union membership rates below 5.0 percent in 2021. South Carolina had the lowest rate (1.7 percent), followed by North Carolina (2.6 percent) and Utah (3.5 percent). Two states had union membership rates over 20.0 percent in 2021: Hawaii (22.4 percent) and New York (22.2 percent). (See chart 2.)

Coronavirus (COVID-19) Pandemic Impact on 2021 Union Members Data

Data on union members for 2020 reflect the impact on the labor market of the coronavirus (COVID-19) pandemic and efforts to contain it. Comparisons with union membership measures for earlier years, including metrics such as the union membership rate should be interpreted with caution. The overall union membership rate and the rates by many demographic and employment characteristics increased despite declines in the number of union members. These increases reflect the disproportionately large decline in total wage and salary employment (mostly among nonunion workers) compared with the decline in the number of union members. Increases in median weekly earnings reflect the disproportionately large decline in employment in 2020, notably among lower-paid workers, such as those in the leisure and hospitality industry. Technical Note

The estimates in this release are obtained from the Current Population Survey (CPS), which provides basic information on the labor force, employment, and unemployment. The survey is conducted monthly for the Bureau of Labor Statistics by the U.S. Census Bureau from a scientifically selected national sample of about 60,000 eligible households. The union membership data are tabulated from one-quarter of the CPS monthly sample and are limited to wage and salary workers. All self-employed workers are excluded.

Definitions

The principal definitions used in this release are described briefly below.

Union members. Data refer to members of a labor union or an employee association similar to a union.

Union membership rate. Data refer to the proportion of total wage and salary workers who are union members.

Represented by unions. Data refer to both union members and workers who report no union affiliation but whose jobs are covered by a union or an employee association contract.

Wage and salary workers. Workers who receive wages, salaries, commissions, tips, payment in kind, or piece rates. The group includes employees in both the private and public sectors. Union membership and earnings data exclude all self-employed workers, both those with incorporated businesses as well as those with unincorporated businesses.
