NOTE: State and area data are currently estimated from 2012 benchmark levels. When more recent benchmark data are introduced with the release of January 2014 estimates, unadjusted data from April 2012 are subject to revision. Area definitions are based on Office of Management and Budget Bulletin No. 10-02, dated December 1, 2009, and available at www.bls.gov/lau/lausmsa.htm. Areas in the six New England states are Metropolitan New England City and Town Areas (NECTAs), while areas in other states are county-based. Some metropolitan areas lie in two or more states. They are listed under the state that appears first in their titles. Davenport-Moline-Rock Island, Iowa-Ill. is the exception in that it is listed under Illinois for operational reasons.
