
Products of rental and leasing of other machinery, equipment and tangible goods (77.30)

SPECIFIC CHARACTERISTICS OF THE INDUSTRY OF RENTING

- A rental business on the rise :

Save time : the right product	defer the investments	Gain in quality : a machine adapted
at the right time	Gain in security :	Enjoy immediately
	maintenance, repair, regulatory constraints	Enjoy immediately

- Directly linked to the economic situation :

- More rental when the activity of the user companies increases
- In times of uncertainty, leasing is preferred to investing
- Key factors by sector : state allocations for public works for the construction, business tourism for air transport, technological evolutions








SPPI - CHARACTERISTICS



- Laspeyres index
- Quarterly periodicity since 2010
- Lower level of granularity :
 - 7731, 7732, 7733, 7739 published
 - for BtoB and BtoAll

=> Used as deflaters in the national accounts and as economic indicators

- Turnover of cpf4 levels coming from the structural business statistics
- Products details are defined by a renewal operation (every 5 years)
 - Sample of firms by cut-off
 - Products (and their weights) provided by INSEE surveyors during a visit to the company,

in order to define representative and easy to follow products

- The price are collected quarterly

- 134 companies
- 613 products



DIRECT USE OF PRICES OF REPEATED SERVICES

- Type of services : construction machinery, earthworks
- Type of machine and equipment : 057-0004 MINIPELLE 2.3 TO 2.8T
- Duration of rental : 1 to 2 days
- Base price invoiced per day for all customers : 105 euros

Try to distinguish the associated services, included or not in the product

CONTRACT PRICING METHOD

- A machine for a given customer
- For large customers who often rent one type of equipment



=> Multiply the number of prices to be recorded=> Exclude the financial leasing.
